As a follow-up to my October 26, 2016 letter, I am writing you to provide an update regarding the Program Area Review that began this fall involving Armour Heights PS, Broadlands PS, Denlow PS, Don Valley (DS, Dunlace PS, Harrison PS, Owen PS, Rippleton PS, St. Andrew's JHS, Windfields JHS, and York (Dills CI.

You may already know that the Program Area Review Geam (PARG) completed its work and made several recommendations that were included in the October 26, 2016 letter. The PARG's report with its recommendations can be found on the GDSB's website (details in last paragraph of this letter).

I would like to let you know that staff has reviewed the PARG's recommendations and is in agreement with all of them. The next step in the process is to present staff's recommendations to the Board of Grustees for approval.
