Dear Parents/Guardians and Community Members:

As a follow-up to my October 26, 2016 letter, I am writing you to provide an update regarding the Program Area Review that began this fall involving Armour Heights PS, Broadlands PS, Denlow PS, Don Valley DS, Dunlace PS, Harrison PS, Owen PS, Rippleton PS, St. Andrew's JHS, Windfields JHS, and York Mills CI.

You may already know that the Program Area Review Team (PART) completed its work and made several recommendations that were included in the October 26, 2016 letter. The PART's report with its recommendations can be found on the TDSB's website (details in last paragraph of this letter).

I would like to let you know that staff has reviewed the PART's recommendations and is in agreement with all of them. The next step in the process is to present staff's recommendations to the Board of Trustees for approval.
